MMS utilizes login validation through LDAP-compliant directory services like Microsoft's Active Directory. The typical user of MMS only needs a single username and password to access their school network and the MMS application. Network administrators only need to manage a single username and password for each teacher, staff member, and student. Password protocol can be configured to coordinate with the MMS SIF agent, automatically adding students to the directory at the time of registration.

Swinchock has seen problems arise with other student information systems that are not as effective as MMS. As a regular attendee of Intermediate Unit meetings and brainstorming sessions, he finds MMS to be head and shoulders above the rest in functionality, especially with regard to state reporting, "With MMS, I get to sit back and remind myself that I don't have the problems that users of other student information systems may have.
